Underserved populations experience additional barriers to reporting sexual assault and additional finance impact.

Abusers can also inflict direct financial harm. Examples: destruction of property, fraud, workplace harassment, thief.

- Legal fees
- Cost of Representation

Secondary Costs

- Unpaid Leave
- Transportation to Court
- Child Care Costs

Workplace and Educational Impact

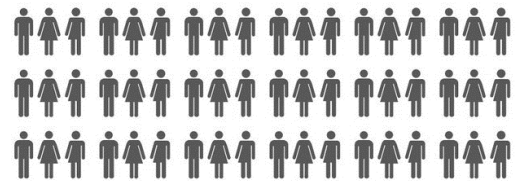
- Unpaid Leave (8.1 days a year)
- Loss of Productivity
- Loss of Development Opportunities
- Drop out or forced out of school
- Transfer Schools
- *does not excuse student load debt

Intangible Expenses

- Pain and suffering
- Psychological distress
- Decreased quality of life
